CASINO COMMITMENT

Chinook Rhythmic Gymnastic Club participates in additional revenue activities to keep our program affordable and accessible. These activities include our club working 2 nights every 18 months to be eligible to qualify for a portion of the proceeds from all charities in a specified fiscal quarter. Our next Casino will probably be in late July or early August 2012.

We require **all parents** to participate so the Club can receive our share of the proceeds. Our last casino provided just over \$60,000 for the Club and provides for our payroll, facilities and government obligations, a huge benefit for our Club. We ask all families to provide a Casino cheque in the amount of \$300, **dated August 1, 2012** and made payable to CRGC as a guarantee that you will fulfill your obligation to assist in working one of the shifts of the casino (one shift per child in the program).

FUNDSCRIP COMMITMENT

Chinook Rhythmique Gymnastic Club began a new program in 2009/2010 that required our parents to participate in the Fundscrip Program. This innovative program allows parents to purchase gift cards through Fundscrip's website and to establish bi-weekly or monthly purchases of local retailers' gifts cards that can be used for groceries, gasoline, entertainment and dining, almost all stores/restaurants that we probably frequent. We buy in bulk and receive a percentage discount (which varies by retailer) and the Club then receives the discount for your purchases. The Club receives a monthly cheque from Fundscrip that represents the past month's group purchases. The Board monitors the amount purchased by each family so that the minimum obligation per family is reached between September 2011 and June 2012. Individual families can reach their minimum as quickly or as slowly as they desire, but once the minimum has been reached, then the discount can be attributed back to the families for credit against gym fees or travel fees attributed from the Club.

The Board has established minimum levels by gymnast involvement so families are treated in a pro-rated format (national gymnast families have the highest fees and thus the highest quota to achieve). The following minimum gross sales levels have been established by the Board for the 2011-2012 program year:

Poppies: \$1,000
Daisies/Performance: \$1,500
Provincial A: \$2,000
Provincial B: \$2,500
National: \$3,000

The Club will assume all rebates for operational expenses and enhancements to the gymnastic experience until minimum levels are reached. After that each family will be earning for their own gymnast's fees or travel obligations. To ensure compliance with this program, the Club **requires a cheque dated for June 1, 2012**, in September 2011 (same as the Casino commitment, but levels are determined by gymnast program) in the following amounts:

Poppies: \$100
Daisies/Performance: \$150
Provincial A: \$200
Provincial B: \$250
National: \$300

Once a family has achieved their minimum obligation in gross sales, then the cheque will be returned.
